All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of Sir Abbott Street in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 107 as shown on a plat of Sherwood Forest, prepared by Dalton & Neves, Engineers, dated November, 1952, recorded in the R.
