NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northerly corner of the intersection of Hunting Hollow Road and Runnymede Road, being known and designated as Lot No. 90 on plat of Foxcroft, Section I, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Hunting Hollow Road, said pin being the joint front corner of Lots 91 and 90, and running thence with the common line of said lots N 37-51 E 150 feet to an iron pin, the joint rear corner of Lots 89, 90, and 91; thence with the common line of Lots 89 and 90, S 52-09 E 150 feet to an iron pin on the northwesterly side of Runnymede Road; thence with the northwesterly side of Runnymede Road; thence with the northwesterly side of Runnymede Road S 37-51 W 125 feet to an iron pin; thence S 82-51 W 35.4 feet to an iron pin on the northerly side of Hunting Hollow Road; thence with the northerly side of Hunting Hollow Road N 52-09 W 125 feet to an iron pin, the point of beginning.
