"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwesterly side of Del Norte Road near the City of Greenville, S. C., being known and designated as Lot No. 314 on plat of Del Norte Estates, Section No. 2, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4N, pages 12 and 13, and having according to said plat the following metes and bounds, to-wit:
