B. Bates, made by R. E. Dalton, Engineer, and recorded in the RMC Office for Greenville County in Plat Book F at Page 32, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a stake on Honour Street 150 feet East of the intersection of Cobb and Honour Streets and corner of Lot No. 28 and running thence along the line of Lot No. 28, N. 48-30 E. 150 feet to a stake at the corner of Lot No. 27; thence along the line of said Lot, S. 55-40 E. 50 feet to a stake, corner of Lot No. 24; thence along the line of Lot No. 24; S. 48-30 W. 150 feet to a stake on Honour Street; thence along Honour Street, N. 55-40 W. 50 feet to the beginning corner.
