All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being shown and designated as Lot No. 5 of Section 7 on a plat entitled East Highland Estates, said plat having been prepared by Dalton & Neves Engineers, dated April, 1959, and recorded in the R.M.C.
