conditions), said note to be repaid with interest as the rate or rates therein specified in installments oftwo hundred eighty
four and 05/100(\$ 284.05) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not soones
paid, to be due and payable 29 years after date; and

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as lot number 43 on a plat of Pelham Estates, Section III, made by Piedmont Engineers & Architects, February 11, 1965, and recorded in the R. M. C. Office for Greenville County in Plat Book 4-G at page 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Belgrade Drive at the joint front corner of lots 43 and 44 and running thence with the line of lot 44, N. 77-47 E., 202 feet to an iron pin at the joint rear corner of lots 43, 44 and 53; thence with the line of lot 53, \bar{S} . 6-30 E., 210 feet to an iron pin at the joint front corner of lots 43 and 53 on the northern side of Ashburn Place; thence with the northern side of Ashburn Place, S. 83-31 W., 180 feet; thence with the curve of Ashburn Place and Belgrade Drive, the chord of which is N. 49-43 W., 34.25 feet; thence with the eastern side of Belgrade Drive, N. 2-57 W., 63 feet; thence continuing with the eastern side of Belgrade Drive, N. 8-17 W., 100 feet to the point of beginning.
