- 6. That he will pay when due all taxes, insurance premiums and public assessments and, on the failure of the Mortgager to pay all taxes, insurance premiums and public assessments, the Mortgagee may, at its option, pay said items and charge all
- 7. That he hereby assigns to the Mortgagee all the rents, issues and profits of the mortgaged premises from and after any default hereunder, and should legal proceedings be instituted pursuant to this instrument, then the Mortgagee shall have the proceedings and the execution of his trust as receiver, shall apply the residue of the rents, issues and profits toward the payment of the debt secured hereby.
- 8. That, at the option of the Mortgagee, this mortgage shall become due and payable forthwith if the Mortgagor shall than-by death of the Mortgagor.
- 9. It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the promissory note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions and covenants of this mortgage and of the promissory note secured hereby, then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue. If there is a default in any of the terms, conditions or covenants of this mortgage or of the promissory note secured hereby, then, at the option of the Mortgagoe, all sums closed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagoe become a party to any suit involving this mortgage or the title to the premises described herein, or should the Mortgagoe become a any part thereof be placed in the hands of an attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagoe, including a reasonable attorney's fee (in any event, not less than 10% of the unpaid balance), shall thereby, and may be recovered and collected hereunder.
