"ALL that certain piece, percel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying end being in the State of South Carolina, County of Greenville, in Bates Township, near Travelers Rest, and being known and designated as Lot No. 10 as shown on a revised map of Lots Numbers 34 and 47 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the RMC Office for Greenville County in Plat Book PP at page 113, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Loraine Drive at the joint front corner of Lots 9 and 10 and running thence with the Southern side of Loraine Drive, S. 87-00 E. 100 feet to a point at the joint front corner of Lots 10 and 11; thence S. 3-00 W. approximately 154 feet to a point in a branch, said point being the joint rear corner of Lots 10 and 11; thence with said branch as a line approximately N. 80-10 W. approximately 100.8 feet to a point in the branch, said point being the joint rear corner of Lots 9 and 10; thence N. 3-00 E. approximately 141 feet to the point of beginning.
