NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgages at any time for advances made to or for his account by the Mortgages, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, located about $oldsymbol{4^1}_2$ miles northwest of the City of Greer and near the Milford Baptist Church, lying on the west side of Joan Avenue, being all of Lot No. 5 and the southern one-half of Lot No. 6 as shown on a plat made for the grantor by H. S. Brockman, Surveyor, dated August 9, 1958, recorded in the R.M.C. Office for Greenville County in Plat Book M. M., at page 25, having the following courses:

BEGINNING on an iron pin on the western side of Joan Avenue or Street, joint front corner of Lots Nos. 4 and 5, and runs thence with the common line of Lots Nos. 4 and 5, S. 83-03 W. 300.4 feet to an iron pin on the Hudson line; thence with line of that property N. 16-50 W. 210 feet to a point in the center of rear line of Lot No. 6; thence a new line and with line of James Miller, N. 83-03 E. 299.3 feet to a point on the margin of Joan Street, corner with James Miller; thence along the margin of said Street, S. 17-10 E. 210 feet to the beginning corner.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise on be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
