WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of NINTEEN THOUSAND AND NO/100----- DOLLARS

(\$ 19,000.00---), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is TWENTY-FIVE years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand, well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 33 on plat of Montclaire, Section III, recorded in the RMC Office for Greenville County in Plat Book WWW at page 57, and having the following metes and bounds:

Beginning at an iron pin on the northwestern side of Archdale Drive at joint front corner of Lot 32 and running thence with Archdale Drive, S 29-18 W 80 feet to an iron pin at joint corner of Lot 34; thence N 62-22 W 150.1 feet to an iron pin; thence with rear line of Lot 33, and Lot 37, N 29-18 E 84.2 feet to an iron pin at rear corner of Lot 32; thence with line of Lot 32, S 60-42 W 150 feet to the point of beginning.

Derivation: Same property conveyed to mortgagors by G. Lynn McCollum by deed to be recorded herewith.

In-addition-to and-together with the monthly installments of principal and interest under the note secured hereby, mortgagor promises to pay to the mortgagee the sum of 1/48% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan, and on his failure to pay it, mortgagee may advance it for mortgagor's account and collect it as a part of the debt secured hereby. THE MORTGAGORS agree that after the expiration of 10 years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of 5 years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to mortgagee as premium for such insurance 1/2% of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
