"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, near Travelers Rest,

and being known and designated as Lot Number 9 as shown on a revised map of Tracts 58, 59 and 60 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book VV, at Page 51, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Northern side of Loraine Drive at the joint front corner of Lots 8 and 9 and running thence with the Northern side of Loraine Drive, N. 86-18 E. 125 feet to a point at the joint front corner of Lots 9 and 10; thence, N. 3-42 W. 173.9 feet to a point at the joint rear corner of Lots 9 and 10; thence, S. 87-11 W. 74.6 feet to a point; thence, S. 86-18 W. 50.4 feet to a point at the joint rear corner of Lots 8 and 9; thence, S. 3-42 E. 175 feet to the point of beginning.
