"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, at the northwestern intersection of Cothran Street and McPherson Lane, being known and designated as Lot No. 15 and the major portion of Lot 14, as shown on a Plat of Property of Charles C. Calhoun and Ruth Pamplin, which Plat is recorded in the R. M. C. Office for Greenville County, in Plat Book "LLL", at Page 61, and having, according to said Plat, the following metes and bounds, to-wit:
