

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on the eastern side of Aberdare Court, being known and designated as Lot No. 117, as shown on a Plat of Kingsgate, Sheet 2, made by Piedmont Engineers & Architects and recorded in the R. M. C. Office for Greenville County, in Plat Book WWW, at Page 45, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Aberdare Court at the joint front corner of Lots 115 and 117, and running thence with the common line of said Lots N. 71-38 E. 146.5 feet to a point; thence S. 16-56 E. 210.0 feet to a point at the joint rear corner of Lots 117 and 120; thence with the common line of said Lots N. 68-39 W. 161.8 feet to a point at the eastern side of Aberdare Court; thence with the curve of the said Court the chords of which are, N. 19-58 W. 25 feet, N. 38-24 W. 61.4 feet, and N. 17-35 W. 24.3 feet, to the point of beginning.
