WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further-sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Elkhorn Drive and being known and designated as Lot No. 39 as shown on a plat of Mountain Shadows prepared by R. B. Bruce, Registered Surveyor, dated April 28, 1969, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book NNNN at page 7 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Elkhorn Drive at the joint front corner of Lots Nos. 38 and 39 and running thence with the line of Lot No. 38 N. 41-0W. 150 feet to an iron pin in the line of Lot No. 35; thence with the rear lines of Lots Nos. 35 and 34 N. 49-0 E. 120 feet to an iron pin at the joint rear corner of Lots Nos. 39 and 40; thence with the line of Lot No. 40 S. 41-0E. 150 feet to an iron pin on the northwestern side of Elkhorn Drive; thence with the northwestern side of Elkhorn Drive; thence with point of beginning.
