NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and essigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville lying on the North side of Avice Dale Drive, being a portion of Lot No. 2 on a plat of Avice Dale, recorded in the R.M.C. Office for Greenville County in Plat Book B at page 53 and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northwest side of Avice Dale Drive, at the joint front corner of Lots Nos. 1 and 2 as shown on said plat, and running thence with the common line of said lots, N. 62-30 W. 200 feet to an iron pin; thence a new line through Lot No. 2, S. 28-30 W. 130 feet to an iron pin; thence another new line in a Southeasterly direction approximately 225 feet to a point on the Northwest side of Avice Dale Drive (said point being S. 20-30 W. 80.7 feet and S. 15-08 W. 49.3 feet from the joint front corner of Lot Nos. 1 and 2 as shown on the aforementioned plat); thence with the Northwest side of Avice Dale Drive, N. 15-08 E. 49-3 feet to an iron pin and N. 20-30 E. 80.7 feet to an iron pin, the beginning corner.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
