"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, lying on the western side of Tubbs Mountain Road, bounded by land now or formerly of Clardy Raymond Edwards and Paul Hunt and containing one and one-third acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western bank of Tubbs Mountain Road, and running thence along that Road N. 11-30 E. 75 feet to a stone on the Hunt line; thence S. 81-02 W. 628.6 feet to a stone on the Edwards line; thence S. 25-00 E. 150 feet to a stake; thence N. 73-28 E. 565.2 feet to the beginning corner.
