IN monthly installments of \$193.96 per month beginning one month from date hereof and \$193.96 on the same day of each month thereafter until the principal with interest to accrue thereon is fully paid provided, however, unless sooner paid, the entire indebtedness shall be due and payable five years from date hereof,

with interest thereon from date at the rate of eight per centum per annum, *** SKEER On 25% of the loan outs tanding & 52% per annum on the remaining 75% of the loan outs tanding.

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, tying and being in the State of South Carolina, County of Greenville, near the City of Greenville, at the intersection of White Horse Road and the Old Augusta Road, and shown as the property of C. B. Traynham and J. A. Traynham, on Plat prepared by J. C. Hill October, 1965, which plat is to be recorded, and said Lot having according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin in the intersection of White Horse Road and Old Augusta Road and running thence with the Eastern side of White Horse Road N. 26-45 W. 174 feet to an iron pin; thence continuing with the Eastern side of said Road N. 36-50 W. 56.8 feet to an iron pin running thence N. 72-52 E. 114.3 feet to an iron pin on the Western side of Old Augusta Road running thence with the Western side of Old Augusta Road S. 0-50 E. 234.2 feet to an iron pin point of beginning.
