NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Jonquil Lane and eastern side of Old Taylors Bridge Road, near the City of Greenville, and known and designated as Lot No. 9 of a subdivision of property of Columbia Investment Company, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book KKK at Page 73, said lot having such metes and bounds as shown thereon.

This is the identical property conveyed to James F. Owens and Ellar S. Owens by W. N. Leslie, Inc., in June, 1966, recorded in Deed Book 799 at Page 383. The said James F. Owens died intestate September 9, 1968, leaving as his sole heirs at law his widow, Ellar S. Owens, his mother, Minnie Mae L. Hembree, and two sisters, Earline O. McDowell and Catherine O. Babb.
