All that certain piece, parcel or lot of land with improvements thereon in the State of South Carolina, Greenville County, Greenville Township, in the City of Greenville, lying on the southern side of E. Faris Road, being known and designated as Lot No. 26, Block F, on a plat of Kanatenah Subdivision, recorded in the R.M.C. Office for Greenville County in Plat Book F, Page 131, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the southern side of E. Faris Road, (formerly Blessingame Street), at the joint front corner of Lots Nos. 26 and 27, which pin is 180 feet west from the intersection of E.
