"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of South Carolina Highway No. 23-278 containing 1.1 acres as shown on a survey dated December 30, 1971, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4M, Page 75, and having according to said Plat the following metes and bounds, to-wit:
