"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Within the corporate limits of the Town of Fountain Inn, being known and designated as Lot No. 12 on a plat prepared by C. O. Riddle, Surveyor, on August 24, 1963, said plat entitled "Property of W. Shell Thackston, Fountain Inn, S. C.", and having, according to this plat the following courses and distances, to-wit:
