"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolins, County of Greenville, flear the City of Greenville, on the north side of Collinson Road, shown as Lot No. 8 on plat of Sylvan Hills, made June 1948, by Piedmont Engineering Service, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book S, Page 103, and having, according to said plat, the following metes and bounds, to-wit:

BECIMING at an iron pin on the north side of Collinson Road, at the joint front corner of Lots 7 and 8, and running thence with the line of Lot 7, N 5-36 W, 150 feet to an iron pin; thence 8 84-24 W, 70 feet to an iron pin; thence with the line of Lot 9, S 5-36 E, 150 feet to an iron pin on the north side of Collinson Road; thence with Collinson Road, N 84-24 E, 70 feet to the point of beginning.
