( 71 %) per centum per annum until paid. The said principal and interest shall be payable at the office of the Association in monthly installments of One Hundred Twenty & 84/100

(\$ 120.84 Dollars, commencing on the July day of , 19<sup>72</sup>, and on the first day of each month thereafter until the principal and interest are paid. Unpaid interest to bear interest thereafter at the same rate. And with interest from the date of said note, and this mortgage securing the same at the same rate until the date of the payment of the first monthly installment.
