together with all rights, interests, easements, hereditaments and appurtenances thereunto belonging, the rents, Issues, and profits thereof and revenues and income therefrom, all improvements and personal property now or later attached thereto or reasonably necessary to the use thereof, including, but not limited to, ranges, refrigerators, or carpeting purchased or financed in whole or in part with loan funds, all water, water rights, and water stock pertaining thereto, and all payments at any time owing to Borrower by virtue of any sele; lease, transfer, conveyance, or condemnation of any part thereof or interest therein—all of which are herein called "the property";
