And said mottgape, agrees incheep the building and improvements now standing or hereafter erected upon the mortgaged premises and any and all apparatus. Some and apparatus now or hereafter in or attached to said buildings or improvements, insured against loss or damage by the and such other hatards as the mortgage may from time to time require, all such insurance be in forms, in companies and in sums (not less than sufficient to avoid any claim on the part of the insurers for co-insurance) satisfactory to the mortgages; that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the snortgages, and that at least fifteen days before the expiration of each such policy, a new and sufficient policy to take the place of the one so expiring shall be delivered to the mortgages.
