Forever:

All that piece, parvel, lot of land in Greenvil.le County, Greenville Township, State of South Capolina, being more fully known and—designated as Lot No. 11 of Block "D" on a Plat of Riverside, recorded in the RMC Office for Greenville County in Plat Book at pages 322-323, and having according to said plat the following metes and bounds to wit; BEGINNING at an iron pin on the southe side of Edgement Avenue, joint corner of Lots Nos. 10 and 11 and running thence along with Line of Lot No.10,125 feet to an iron pin on a 15 foot Valley; thence with the north side of said alley, 64 feet to an iron pin on the west side of Sumpter Street 125 feet to an iron pin on the corner of Edgement Avenue and Sumpter Street; thence with Edgement Avenue in a westerly direction 64 feet to the BEGINNING corner

This lot containg a five room frame house.
