

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the northeast side of Mauldin Circle and being known and designated as Lot 11 of a subdivision known as Mauldin Meadows as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book EE at Page 151 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Mauldin Circle at the corner of Lot 10 and running thence along the line of said Mauldin Circle, N. 49-15 W. 48.6 feet to an iron pin; thence continuing along the line of said Mauldin Circle, following the curvature thereof, N. 69-09 W. 21.4 feet to an iron pin on the northern side of said Mauldin Circle, the corner of Lot 12; thence along the line of that lot, N. 3-45 W. 204 feet to an iron pin, part of an axle; thence S. 48-52 E. 213 feet to an iron pin at the/corner of Lot 10; thence along the line of that lot, S. 40-45 W. 138.8 feet to the beginning corner; being the same conveyed to me by J. H. Mauldin by deed dated March 6, 1957, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 573 at Page 435.
