All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Travelers Rest, being known as Lot 38 on plat of Sunny Acres recorded in the RMC Office for Greenville County in Plat Book BB at Page 168 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Cox Drive at the corner of Lot 37 and running thence with said Drive S 56-05 W 75 feet to an iron pin; thence N 33 W 154.3 feet to an iron pin; thence N 57 E 75 feet to an iron pin; thence S 33 E 156.9 feet to the point of beginning, and being one of the lots conveyed to the Mortgagor in Deed Book 939 at page 104, and subject to restrictions in Deed Book 496 at page 129 and to an agreement to widen the road with the County.
