"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as lot no 97 on a plat of Brook Glenn Gardens, recorded in Plat Book JJJ at Page 85 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
