14. That in the event this mortgage should be forcelosed, the Mortgagor expressly waives the benefits of Sections 45-88 through 45-96.1 of the 1962 Code of Laws of South Carolina, as amended, or any other appraisement laws.

THE MORTCACEE COVENANTS AND ACREES AS POLLOWS:

- 1. That should the Mortgagor prepay a portion of the indefendences secured by this mortgage and subsequently fail to make a payment or payments as required by the aloresaid promissory note, any such prepayment may be applied toward the missed payment or payments, insofar as possible, in order that the principal debt will not be held contractually delinquent.
