C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor—in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being approximately one-half (1) of lot #20, as shown on a plat of J. Waymon Smith, recorded in the Office of the R. M. C. for Greenville County in Book 233 at page 305, and plat recorded June 13, 1967 and having the following courses and distances to wit:

Beginning at an iron pin, corner of Lot #21, Will Oriffith Land, at a County Road, and runs thence S. 30-27 E. 143.7 feet to an old Stone; on the D. F. Smith line; thence down the Smith line S. 52-56 W. 223.3 feet to a stake; thence N. 53-16 W. 104.7 feet to a nail in the said County Road; thence up said County Road N. 37-29 E. 278 feet to an iron pin, the point of beginning.
