

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor in the Mortgagor's account, and also in consideration of the sum of Three Dollars is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estaté:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 123 on plat of Hillsborough, Section 2, recorded in Plat Book 4 F at page 51 in the RMC Office for Greenville County, and fronting on Basswood Drive, having the following metes and bounds:

Beginning at an iron pin on the northeastern side of Basswood Drive at joint front corner with Lot 124; thence N 57-24 E 140 feet to an iron pin; thence S 32-36 E 110 feet to an iron pin; thence with Lot 122, S 57-24 W 140 feet to an iron pin on Basswood Drive; thence with said Drive, N 32-36 W 110 feet to the beginning corner.
