All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as Lot #23 of a subdivision known as Pilgrims Point according to a plat that was prepared by Piedmont Engineers and Architects and recorded in the R.M.C. Office for Greenville County in Plat Book WWW at Page 35 and having according to said plat the following metes and bounds to-wit:
