"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Iown—ship, lying on the southern side of Hammett Road, being shown and designated as Lot B on a plat of the property of Richard R. Perdue, prepared by Webb Surveying and Mapping Co., dated November, 1968, revised through February, 1972, and having, according to said plat, the following courses and distances, to—wit:

BEGINNING at a point in the center of Hammett Road at the joint front corner of Lots A and B as shown on the aforementioned plat and running thence with Hammett Road, S. 60-09 E. 148.5 feet and S. 47-46 E. 100 feet to a point in the center of said road and at the joint corner with a 50 foot strip; thence with the common line of Lot B and the 50 foot strip, S. 37-20 W. 442.8 feet to an iron pin; thence N. 58-48 W. 165 feet to an iron pin at the joint rear corner of Lots A and B; thence with the common line of said lots N. 26-54 E. 457.2 feet to a point in the center of Hammett Road, the point of beginning.
