All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Southwestern corner of the intersection of Merrifield Place with Merrifield Court, being shown and designated as Lot No. 99 on a Final Revised Plat of Map No. 1 of FOX-CROFT, Section 2, made by C.
