All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of West Sable Court, being shown and designated as Lot 32 on a plat of Blue Mountain Park prepared by Beeson Engineering Company dated March 16, 1955, recorded in the RMC Office of the Greenville County Courthouse in Plat Book EE at Page 121 and being described, according to said plat, more particularly, to-wit:
