The Mortgagor covenants that he is lawfully setted of the premises havenapove described in the absolute, that he has good right and lawful authority to sell tourwey or escurable the same and that he ises are free and clear of all liens and encumbrances whatsoever. The Mortgago further coverage to forever defend all and singular the premises unto the Mortgago torever, from and against the Mortgago all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note at the times and in the manner therein provided.
- 2. That the rights of the Mortgageo arising under the clauses and covenants contained in this mortgage shall be separate, distinct and cumulative and none of them shall be in exclusion of the others; that the invalidity of one or more of the clauses and covenants contained herein shall not in any way affect the validity or enforceability of the remaining provisions herein contained; and that no act of the Mortgagee shall be construed as an election to proceed under any one provision herein to the exclusion of any other provision, any thing herein or otherwise to the contrary notwithstanding.
