

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Tussock Road and being known and designated as Lot No. 241 on a plat of DEL NORTE ESTATES, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4N at Pages 12 and 13, plat of which is known as Sections 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Tussock Road at the joint front corner of Lots 241 and 242 and running thence with the common line of said Lots S.46-30 E. 127.0 feet to an iron pin at the joint rear corner of said Lots; thence N.43-30 E. 100 feet to an iron pin at the joint rear corner of Lots 241 and 242; thence with the common line of said Lots N.46-30 W. 127 feet to an iron pin at the joint front corner of said Lots on Tussock Road; thence with said Road S.43-30 W. 100 feet to the point of beginning.
