"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the north side of Legave Street and on the west side of Wilshire Drive (formerly known as Brookwood Drive) being shown as Lots 27, 28 and 29 of Block D, of Stone Estates recorded in Plat Book G, Page 292 and having, according to said plat, the following metes and bounds, to-wit:
