

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, self and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeasterly side of Altamont Road on Paris Mountain in the County of Greenville, State of South Carolina, and having according to an unrecorded survey plat of the property of Hazel R. Crooks, made by Campbell & Clarkson, dated March 8, 1968, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Altamont Road, said pin being the joint corner of the property herein conveyed with property belonging to Furman University and running thence along the northeasterly side of Altamont N 25-22 W 185 feet to an iron pin; thence continuing with the northeasterly side of Altamont Road N 29-53 W 15 feet to an iron pin; thence turning and running N 64-50 E 446.2 feet to an iron pin; thence turning and running S 31-38 E 200 feet to an iron pin, corner of the aforementioned property belonging to Furman University; thence turning and running with the line of the Furman University property S 64-41 W 466.8 feet to the point of beginning.

This mortgage is junior and subordinate to that certain mortgage given by Ray E.

Landreth to First Federal Savings and Loan Association in the original amount of \$35,000.00, dated November 26, 1971 and recorded in the RMC Office for Greenville County, S. C. in Mortgage Book 1214, page 596.
