

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 117 of a subdivision known as South Forest Estates as shown on plat thereof being recorded in the R.M.C. Office for Greenville County in Plat Book GG at Page 181 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Stratford Road at the joint front corner of Lots 117 and 118 and running thence with the joint line of said lots, S. 71-44 W. 164.9 feet to an iron pin in the rear line of Lot 124; thence N. 14-45 W. 80.2 feet to an iron pin; thence with the joint line of Lots 116 and 117, N. 71-44 E. 160 feet to an iron pin on the western side of Stratford Road; thence with the western side of Stratford Road, S. 18-16 E. 80 feet to the beginning corner; being the same conveyed to me by Eugene Thomas and Doris A. Thomas by deed of even date to be recorded herewith.
