NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and be fore the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, on the eastern side of LeGrand Boulevard, and being known and designated as Lot No. 264 as shown on plat of Sherwood Forest recorded in the R. M. C. Office for Greenville County in Plat Book GG at pages 70 and 71, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the eastern side of Legrand Boulevard at the joint front corner of Lots Nos. 25 and 264 and running thence along said Boulevard, N. 49-11 W. 205.5 feet to an iron pin; thence N. 29-34 E. 163.1 feet to an iron pin; thence S. 49-11 E. 255.5 feet to iron pin; thence along the line of Lot No. 25, S. 40-49 W. 160 feet to the point of beginning.
