with interest thereon from date at the rate of eight per centum per annum, to be paid: annually from date hereof WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying on the East side of the Buncombe Road, about 12 miles northwest from the City of Green, being all of Lots No's 26,27,28,29 and 30 en a plat of preperty made for C.L. King by S.C. Moen, Surveyen, dated April, 1941, which plat is on reword in the R.M.C. Office for Greenville County in Plat Book L, at page 187, said lots frenting 278 feet on the East side of the said Buncombe Road, beunded on the north by the W.W. Burgiss Estate, by Kelley on the South, on the East by H.W. Couch, on the West by Buncombe Road, Reference to the record of the aforesaid plat is hereby made for a more detailed description of said lots.

This is the same property conveyed to me by deed from B.R. Chandler, dated the 2nd day of February, 1946, and recorded in the R.M.C. Office for Greenville County in Vel. 287, at page 229.

Together with all and singular rights, members, harditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever tawfully claiming the same or any part thereof.
