as evidenced by promissory note of even date herewith, payable to the order of Mortgagee in consecutive

NOW, KNOW ALL MEN BY THESE PRESENTS, That the said Mortgagor in consideration of the said debts and sums of money aforesaid, for the better securing the payment thereof, and also to secure the payment of any other sums advanced to said Mortgagor under the terms and provisions of this Mortgage, as hereinafter set forth, to the said Mortgagee according to the condition of said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Mortgagee, its successors or assigns, the following

described property situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, aforesaid, lying and being on the southern side of Fairlawn Circle, being known and designated as lot No. 19 on plat of Fenwick Heights Subdivision, Section 2, plat of which is recorded in Plat Book 100 at Page 45 in the RRC Office for Greenville County and having, according to said plat, the following metes and bounds, to wit:

BEGGING AT AN IRON PIN ON THE SOUTHERN SIDE OF FAIRLAWN CIRCLE, JUNCT FRONT CORNER OF LOTS 15 AND 16 AND RUNNING THENCE WITH THE COMMON LINE OF SAID LOTS, S. 20-15 E. 100.0 feet to AN IRON PIN THENCE S. 65-54 W. 100.0 feet to AN IRON PIN AT THE JUNCT REAR CORNER OF BOTH LOTS 14 AND 15 THENCE WITH THE COMMON LINE OF SAID LOTS, N. 71-20 E. 100.0 feet to AN IRON PIN ON THE SOUTHERN SIDE OF FAIRLAWN CIRCLE, THENCE WITH SAID CIRCLE, W. 00-00 E. 75 feet to AN IRON PIN, THE POINT OF BEGINNING;
