- (4) Whither or not the note is insured by the Government, the Government may at any time pay any other amounts required herein to be paid by Borrower and not paid by him when due, as well as any costs and expenses for the preservation, protection, or enforcement of this lian, as advances for the account of Borrower. All much advances shall bear interest at the rate borne by the note which has the highest interest at the rate borne by the note which has the highest interest.
- -(5) All advances by the Govarnment as described in this instrument, with interest, shall be immediately due and payable by Borrower to the Government without demand at the place designated in the latest note and shall be secured hereby. (8) To keep the property insured as required by and under insurance policies approved by, delivered to, and retained by the Government.

(5) To seep us property insures as required by, and under insurance portices, approved by, described to, and received by the Government; operate the property in a good and husband-manilks manner; comply with such farm conservation practices and farm and home management plans as the Government-from time to time may preactibe; and not to abaddon the property, or cause or permit waste, leasening or impairment of the security covered hereby, or, without the written consent of the Government, cut, remove, or lease any timber, gravel, oil, gas, coal, or other minerals except as may be necessary for ordinary domestic purposes.

(10) To comply with all laws, ordinances, and regulations effecting the property; .

- (ii) To pay or reimburse the Government for expenses reasonably necessary or incidental to the protection of the lien and priority hereof and to the entoucement of or the compliance with the provisions hereof and of the note and any supplementary agreement (whether before or after default), including but not limited to costs of evidence of title to and survey of the property, costs of recording this and other instruments, attorneys' fees, trustees' fees, court costs, and expenses of advertising, selling, and conveying the property.
- (12) Neither the property nor any portion thereof or interest therein shall be lessed, assigned, sold, transferred, or encumbe wolding rily or otherwise, without the written consent of the Government. The Government shall have the sole and exclusive rights wolfagenty or otherwise, without the written consent of the Dovernment. The Government shall have any approximations, and satisfaction, and no insured lender shall have any right, little or interest in or to; the light or any benefits hereof.
- (13). At all reasonable times the Government and its agents may inspect the property to sacertain whether the covenants and agreements contained herein or in any supplementary agreement are being performed.
- (14) The Government may extend and defer the maturity of and renew and reamortize the debt evidenced by the note or any indebtedness (14) The Government may extend and upper one majority of and removating the Government course of the covernment is excured hereby, release from liability to the Government any party so liable thereon, release portions of the property from and subordinate the lien hersof, and walve any other rights hereunder, without affection the lien or printity hereof of the liability to the Government of Borrower or any other party for payment of the note or indebtedness secured hereby except as specified by the
- (15) If at any time it shall appear to the Government that Borrower may be able to obtain a loan from a production credit association, a Foderal land bank, or other responsible cooperative or private credit source, at reasonable rates and terms for loans for similar purposes and periods of time.  (17) SHOULD-DEPAULT occur in the performance or discharge of any obligation secured by this instrument, or should any one of the parties named as Borrower die or be declared an incompetent, a bankrupt, or an insolvent, or make an assignment for the benefit of creditors, the Government at its option, with or without notice, may: (a) deglare the entire amount unpaid under the note and any indebtedness to the Government hereby secured immediately due and payable, (b) for the account of Borrower incur and pay reasonable expenses for repair or maintenance of and take possession of, operate'or rent the property, (c) upon application by If and production of this instrument, without notice of hearing of said application, have a receiver appointed for the property, with the usual powers of receivers in like cases, (d) foreclose this instrument as provided herein or by law, and (e) enforce any and all other rights and remedies provided herein or by present or future law.
- (18) The proceeds of foreclosure sale shall be applied in the following order to the payment of: (a) costs and experises incident to enforcing or complying with the provisions hereof, (b) any prior lieus required by law or a competent court to be so paid, (c) the debt evidenced by the note and all indebtedness to the Government secured bereby, (d) infaitor lieus of record required by law or a competent court to be so paid, (e) at the Government, option, any other indebtedness of Borrower owing to or insured by the Government, and (f) any balance to Borrower. At foreclosure or other sale of all or any part of the property, the Government and its agents may be and purchase as atranger and may pay the Government's share of the purchase price by crediting such amount on any debts of Horrower owing to or insured by the Government. In the order oreacribed above. insuged by the Government, in the order prescribed above.

(19) As against the debt evidenced by the note and any indebtedness to the Covernment hereby secured, with respect to the property, Borfower (a) hereby relinquishes, waives, and conveys all tights, inchosts or consummate, of descent, dower, curtesy, homestead, valuation, appraisal, and exemption, to which Borrower is or becomes entitled under the laws and constitution of the jurisdiction where the property lies, and (b) hereby agrees that any right provided by such laws or constitution for redemption or possession following foreclosure sale shall not apply, and that no right of redemption or possession shall exist after foreclosure sale.

(20) This instrument shall be subject to the present regulations of the Farmers Home Administration, and to its future regulations
