(\$ 30,600.00° ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note; and payable as therein stated or as modified by mutual agreement; in writing, the final maturity of which , years after the date hereof, unless extended by mutual consent, the terms of said note and any aggrement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indubted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or horeafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, being shown as Lot No. 18 on plat of Forrester Woods, Section I, dated March 14, 1972, prepared by R. B. Bruce, R. L. S., and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4N at Page 78. Reference to said plat is hereby craved for a more particular description.

BEGINNING at a point on the Southwestern side of the intersection of Cold Springs Place and Old Hickory Point and running S. 42-30 W. 132.4 feet to the joint rear corners of Lots 18 and 19; running thence N. 60-30 W. 151 feet to a point; running thence N. 25-01 E. 145 feet to the joint rear corners of Lots 17 and 18; running thence S. 72-24; E. 124.7 feet to a point on the Northwestern side of the intersection of Cold Springs Place and Old Hickory Point; thence with the curve of said intersection S. 10-21 E. 60 feet to a point on the said intersection; thence continuing with said intersection \$. 69-09 E. 32 feet to the point of Beginning.

"In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pays to the mortgages for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in sayment of the mortgage guaranty insurance covering this loan and on his failure to pay it; the mortgagee may advance it for the mortgagor's amount and collect it as part
