MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (33.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, barganed, sold, and released, and by these presents does grant, hargain, sell and release unto the Mortgagee, its successors and assigns, the following described real entate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lylog and being in the State of South Caroline, County of Greenville, on the western side of Woodbarry Way, being shown as Lot No. 17, on plat of Property of Hollyyale, as recorded in the RMC Office for Greenville County, S. C., in Plat Book "Y", at Page 131, and having, according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Woodberry Way at the joint front corner of Lots Nos. 17 and 18 and running thence along the joint line of said lots, N. 70-31 W. 255 feet to an Iron pin, the joint rear corner of said lots, thence along the creek as a line, a traverse line being S. 12-52 W. 114.5 feet to an Iron pin, joint rear corner of Lots Nos. 16 and 17; thence along the joint line of said lots, S. 75-12 E. 249 feet to an Iron pin on the western side of Woodberry Way, thence along the western side of Woodberry Way, N. 15-43 E. 95 feet to the point of BEGINNING.
