MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) (SEND GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE. SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Dollars as evidenced by Mortisagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions - said note to be repaid with interest as the rate or rates therein specified in installments of Eighty-One

and 11/100

(\$ 81.11

) Dollars each on the first day of each month bereatter in advance, until the principal sum with interest har been paid in full, such payments to be applied first to the payment of interest computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

5 / years after date, and

WIFREAS said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpout for a period of thirty class, or if there shall be any failure to comply with and abide by any By-Laws of the Charter of the Morteager, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become unmediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars \$100. To the Mortgagor in hand well and truly paid by the Mortgage at and before the sealing of these presents, the receipt whereof is hereby as knowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgage its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, stuate, lying and being in the State of South Carolina, County of Greenville, State of South Carolina, near the corporate limits of Greenville, as follows:

LOT #1 on plat of subdivision of Lila Lee Sewell's property and having the following courses and distances:

BEGINNING at an iron pin on the west side of Anderson Street, corner of Nelson property, running thence N. 45-30 W. 140 feet to an iron pin, corner of Lot #5; thence with line of Lots #5 and 6, S. 47 W. 94 feet to an iron pin, corner of Lot #2, S. 43 E. 140 feet to an iron pin on Anderson Street; thence with Anderson Street N. 47 E. 100 feet to the beginning corner.

THIS is the same property conveyed to Sullivan C. Franks, who died testate in 1968, by Edward J. Howard, by deed dated January 24, 1941, and recorded in the R.M.C. Office for Greenville County in Deed Book 230, at page 69.
