Should any legal proceedings be instituted for the foreclosure of this mortgage, or should Cameron-Brown Company become a party to any suit involving this Mortgage or the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of an attorney at law for collection by suit or otherwise, all costs and expenses incurred by Cameron-Brown Company, and a reasonable attorney's fee, shall thereupon become due and payable, immediately or on demand, at the option of Cameron-Brown Company, as a part of the debt secured hereby, and may be recovered and collected hereunder.
