TO HAVE AND TO HOLD all and singular the sail premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, univer, or encumber the same, and that the premises are free and clear of all liens and encumbrances what he worker. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagoe forever, from and against the Mortgagos and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note
 at the times and in the manner therein provided, or as modified or extended by mutual agreement in writing.
- 2. That this mortgage shall secure the Mortgages for such further sums as may be advanced hereafter, at the option of the Mortgage, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein, and also any further loans, advances, readvances or credits that ally be made hereafter to the Mortgagor by the Mortgagee, and for any other or further obligated by the Mortgagor at don't time hereafter; and that all sums so advanced shall be are interest at the same rate as the Mortgage debt and shall be payable on demand of the Mortgagee; unless otherwise provided in writing; and the lien of this mortgage securing such advances and readvances shall be superior to the rights of the holder of any intervening lien or encumbrance.

.3. Without affecting the liability of any person obligated for the payment of any indebtedness secured hereby, and without affecting the rights of the Mortgagee with respect to any security not expressly released in writing, the Mortgagee may at any time, without notice or consent, make any agreement extending the time or therwise altering the terms of payment of the indebtedness secured hereby.

- 4. That he will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time to the Mortgage against loss by fire and other hazards, pasualtic and contingencies in such amounts and fossich periods as may be required by the Mortgage and will pay promply, when due, any premiums on such insurance provision for payment of which has not been made hereinbefore all insurance shall be carried in companies approved by the Mortgage and the policies and renewals thereof shall be held by the Mortgage and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgage. He event of loss Mortgagor will give immediate notice by mail to the Mortgage, who have make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgage instead of to the Mortgagor and Mortgage jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgage at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. In event of foreclosure of this mortgage or other transfer of the to the Mortgagor in and to any insurance policies then in lorce shall pass to the purchaser or grantee.
- 5. That he will keep all improvements now existing or hereafter erected upon the mortgaged property in good repair, and, in the case of a construction loan, that he will continue construction until completion without interruption, and should he fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- 6. That the Mortgagee may require the maker, co-maker or endorser of any indebtedness secured hereby to carry life insurance upon himself in a sum sufficient to pay all sums secured by this mortgage, designating the Mortgagee as beneficiary thereof, and, upon failure of the Mortgager to pay the premiums therefor, the Mortgagee may, at its option, pay said premiums, and all sums so advanced by the Mortgagee shall become a part of mortgage debt.
- 7. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgages, on the first day of each month, until the indebtedness secured hereby is paid in full, a sum equal to one twelfth of the annual taxes, public assessments and insurance premiums, as estimated by the Mortgages, and, on the failure of the Mortgages to year all taxes, insurance premiums and public assessments, the Mortgages may at its option, pay and fems and charge all advances therefor to the mortgage debt. These monthly escrow payments will not bear interest to the mortgagor(s).
- 8. That he hereby assigns all the rents, issues, and profits of the mortgaged premises from and after any default hereunder, and should legal proceedings be instituted profits instrument; then the Mortgagee shall have the right to have a receiver appointed of the sents, issues, and profits, who, after deducting all charges and expenses attending such proceedings and the execution of his trust as receiver, shall apply the residue of the rents, issues, and profits, toward the payment of the debt secured hereby.
- 9. That, at the option of the Mortgagee, this mortgage shall become due and payable forthwith if the Mortgagor shall convey away said mortgaged premises, or if the title shall become vested in any other person in any manner whatsoever other than by death of the Mortgagor, or, in the case of a construction load, if the Mortgagor shall permit work on the project to become and remain interrupted for a period of affect (15) days without the written consent of the Mortgagee.
- 10. It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed that there is a default under this mortgage of in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue. If there is a default in any of the terms, conditions or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgagee, all sums then owing by the Mortgagor, to the Mortgagee shall become immediately due and payable and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagee become a party to any suit involving this Mortgage or the title to the premises the shield hereby, or should the debt secured hereby or any part thereof be placed to the hands of an intomey at law for collection by suit or otherwise all costs and expenses incurred by the Mortgagee, and a reasonable attorneys; fee, shall thereupon become, due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured thereby, and may be recovered and collected herebyers.
